- **For use of the gym, the sauna-area and the swimming pool the corresponding opening hours apply.**
- *****Adolescents:** Upon reaching the age of majority, the adult rate becomes due. Adolescents need the declaration of consent from their legal guardian. Please bring the following with you when you register: **identity card, passport oder student-ID.** If no parent or legal representative can be present at the registration a copy of the **legal representative's identity card will have to be provided!** Weight-training is possible for adolescents from the age of 14. **Under 16 y.o. weight training and participation in the course program is only possible after presentation of a sports doctor's examination certificate.** Weight-training is only allowed after an appointment with one of our trainers!
- **Club swimming children:** Can terminate the contract with a notice period of 4 weeks to the 30th of June and the 31st of December of the current year (*see cancellation*).
- **Health-tariff:** A valid rehab sports prescription is required. The contract ends automatically when the rehabilitation sports prescription ends; at the latest after 18 months. There is a special right of cancellation to 31.03./30.06. /30.09./31.12. in the current year with a notice period of 4 weeks (see Cancellation).
- **SRH students/SRH specialist students:** Need a valid student-, resp. specialist-student-ID. The contract ends automatically at the end of the month upon completion of studies/training (*see cancellation*).
- **The contribution payments:** shall be made exclusively by direct debit. Exceptions require the consent of the managing director or his/representative. Membership fees must be paid in advance.
- **Membership fees:** are a debt to be discharged in accordance with the provisions of the BGB. They must be paid regularly. The departing member remains obliged to pay the contribution until the cancellation becomes effective. If the direct debit is not honoured, processing fees will be charged by the respective banks together with the membership fee. We charge a processing fee of 5 euros each for additional administrative expenses resulting from reminders and returned direct debits.
- **Cancellation:** Can be cancelled at the end of the year (31 December) with a notice period of 4 weeks. Cancellation must be made in writing. We will confirm the cancellation by post. The cancellation is effective upon receipt of the confirmation of cancellation.
- **Category change:** Can only be requested in writing. We charge a fee of 20 euros for downgrades. Changes received by us after the 20th of the month can only be adjusted with effect from the following month. The current rate for the selected category always applies.
- **Sport & health:** Every customer trains on their own responsibility. Make sure that you meet the health requirements to take part in the sports, course and training program.
- **Special case:** Should the SRH Campus Sports e.V. close by order of the authorities, the membership fee must still be paid.

Issue of SEPA direct debit mandate (The SEPA Direct Debit Scheme can only be used within Germany)
